Meeting called to order at 7:00 at Tuckahoe by the President.

Secretary sent out March minutes. Minutes accepted.

Assistant General Manager's Report:

- Jeff said he is coming this week to set the Intermediate and Wading Pools up. Once opened up, I can renew the permits for them.
- We had a health department inspection that we passed.
- I am having more guards reach out to start picking up shifts. The week of May 1st, I am hoping we can reduce the number of offset schedule days, as I have more of the college age guards returning then.
- I am still working on staffing overall and with this Friday being Olivia's last day things could get tight again. We have been working on reaching out to the local high schools to recruit, but we will likely need adult pool operators.
- I have been working with Ed and have some new trash cans and recycle bins. We have also gotten a few new pool signs to reenforce some common rules violations:
 - No Eating
 - No Diaper Changing
 - No Glassware

Committee Reports

Operations: Chris Bassler

- Meeting later this month
- Need to get contracts for associate members finalized
- Preparing for summer season usage

Engineering and Maintenance: Ed Cho

- Small gas leak at the SBH meter; Washington Gas came out to fix it.
- Pest control came to inspect the SBH to address evidence of termites and mice; also going to inspect the WBH in the spaces above the offices and yoga room. The plan is for the entire WBH to be inspected.
- Pipe leak to the hot tub; Jeff Allen repairing.
- Sewage pipe disconnected/broken in the SBH; being repaired.
- New pressure release valve and pressure reducer components installed for the hot water boilers to the indoor pool. These were not operating properly or at all. In addition, general HVAC service & maintenance contract will expand to include outdoor pool heaters, indoor pool boilers, WBH hot water heater (locker rooms), hot tub boiler, and split heat pump at SBH, in addition to the 5 A/C units at the WBH. A new contract is being prepared and finalized.
- Conducted a Grounds Guys landscaping walkthrough to assess the work done and to be completed under the existing contract and work to be done going forward. A new contract is being prepared and finalized.
- Met Critical Systems PoolPak rep to examine HVAC recommendations; met with referred CTA Engineer rep for site visit previewing condition assessment of WBH air quality.
- Actively prepping for the summer: replacement of 5 broken umbrellas at patio and intermediate/baby pools; replacing broken or cracked patio tables with new synthetic polymer slat top all weather tables under which current chairs can fit; broken deck and lifeguard chair umbrellas replacements; out of date AEDs in WBH and possible AED kit for tennis courts; additional proper signage around pool deck areas; removing yellow tape under garage doors; refresh of SBH lobby and locker rooms (Aesthetics Committee has recommended paint color options and lobby desk configuration); replacement of several trash bins and the addition of new blue logo'd recycling bins; possible outdoor foosball table (TBD); playground mulch to be added to the playground; and new drop ceiling tiles in WBH (hired Mohamad to assist in the painting and repairing work).
- Exploring efficient options to cool the SBH grille/kitchen and SBH lobby; current set up is inadequate.
- Waiting for Surge Tank, tentative May installation by Jeff Allen.
- Club Benchmarking full facility visits complete; first draft of the capital reserve study report to be submitted soon; presentation of report TBD.

- Dues collection is underway will have a better idea at the end of April
- Overall, we are in a good place with our budget

- **Newsletter:** we need updates no later than April 24th from each of the chairs. An email has been sent.
- **Point of Sale (POS):** The current Gift Rocker solution is not working well. It's very hard to reconcile the grille purchases back to the accounting system. Therefore, we worked with Cheryl to find a solution that will work easily with QuickBooks. We all determined (including the new Grille Manager Max) that Square would be the best solution. There is a minimal cost of \$149 for the equipment and 2.6% + 10 cents per transaction for the fee. We will need to build this into the price of the items.
- **Club Automation:** We also talked with Cheryl, and she felt that it's getting better, and it just took some getting used to. She does not want to change the policy on the waitlist policy to only allow cash/check until we get through the dues season. She said it would be hard to change this and cause more work right now. Changing the policy could allow us to go with the other credit card processor that is supported by Club Automation. She also mentioned that she was able to help Tory pull what he needed for classes.
- Club Automation Waiver: When you first log in to Club Automation, there is a waiver, but this is a waiver between Tuckahoe and the member. This will not be enforced by Tuckahoe.
