Secretary sent out February minutes. Minutes accepted.*

President's Report

- Nothing to report.

Executive Committee

- Code of Conduct Draft has been circulated; welcome Board's feedback before being shared with the Membership.
- Multi-Year Strategy Plan has been drafted and is being fine-tuned; please stand-by for circulation.

Manager's Report

Items being worked on around the club:

- Several items have begun to prepare for opening in May:
 - The Pavilion walls have been removed and stored.

- Solar pool covers have been removed and stored.
- Decks have been pressure washed (almost done with this, still need to do baby pool and sections of the Grille patio).
- SBH locker rooms have been emptied and prepped for spring cleaning.
- Offseason documents have been stored in attic spaces to make room for event storage.
- Deck furniture is in the process of being cleaned.
- The slide has been washed.
- Diving boards being inspected by Springboard Specialist.
- Many more preparation items are being done around the Club.
- The pine trees at tennis courts have been removed. We are seeking some expert recommendations/estimates on replacing with low maintenance ‘barrier’ trees to be evaluated by E&M.
- Supernova Maids is coming last week of April to do spring cleaning in SBH before May.
- The Grounds Guys are beginning landscaping. Spring cleanup and weeding on April 17, mulch installation on April 19. Mulch installation is part of our seasonal agreement with them that starts on May 1, but as a courtesy they will begin the contracted items early so we are ready for the first weekend of May.
- Many outdoor projects to prepare for summer are happening around the club. Please reach out if there is something you know needs attention or if you are seeking an update on a particular item! (this is my first spring at Tuckahoe too, so help and feedback is appreciated).

Events:

- Easter Egg hunt went really well. About 70 attendees – we had to move the date due to rain, but it did not seem to negatively affect our expected numbers.
- The pickleball kickoff had a lot of enthusiasm and had over 70 attendees.
- Cinco de Mayo is going to be a new event this year. It fits in well with our first weekend that the Grille will be operating and can serve the taco bar. We will also serve drinks. Pre-registration is required due to insurance at the moment, and walk ups are allowed for food at Cinco de Mayo.

Grille Manager / Event Coordinator:

Welcome Miriah Allen as the new Grille Manager / Event Coordinator. She started on April 8.

Summer Staffing:

We have been working hard at hiring and staffing for the many areas of the Club (lifeguards, Grille, events, front desk, tennis attendants). We are in a good place with each group now (have conducted over 30 Grille interviews, 15 front desk interviews, and I am not sure how many lifeguard interviews – but very many!). Many of the lifeguard applicants are pending successful training, of which we have conducted 1 class in April, and have 2 more in May, as well as an operator class.

We are developing a hospitality and department training to be conducted during the Club closure on May 22, and instituting monthly in-service training for emergency response that will begin in May and continue through the summer (probably past).

- Working on doors/walls to enclose the swim team area in summer bath house.

- Getting quotes for parking lot as we are starting to see some wear and tear.
- Winter bath house HVAC vendors are engaged.
- Tree removal completed and looking at plans for replacement and cleanup along Great Falls.

Finance: Brian Hult

- Dues are coming in a bit slower than before versus last year. However, still 2 weeks to go.
- Morning masters ahead of plan, but the 2023 payment is delayed.
- Aquatics is ahead of plan due to more private swim lessons.
- Club is seeing a higher interest year over year.
- Staffing expenses year over year are slightly higher.
- Club maintenance is also up slightly year over year.
